Elite Athletes Performance Recognition Scheme

Application Guidelines 2026/27

Introduction

The **Elite Athletes Performance Recognition Scheme (the “EAPRS”)** was launched in 2015 by the Government under the Hong Kong Athletes Fund (the “HKAF”) to honour the dedication of athletes in sport and their achievements in representing Hong Kong in major games and competitions. The EAPRS provides a one-off grant to athletes who have officially retired from Team Hong Kong, China on or after 1st January 2015, offering enhanced support for their transition into post-athletic careers and further development. The key features of the EAPRS are shown as follows:

The Grant

A one-off cash grant will be awarded to eligible retired athletes based on their attained EV score and total years of full-time training. The grant amount is calculated with reference to the prevailing Standard Elite Training Grant (the “ETG”) for Elite A+ of the Hong Kong Sports Institute (the “HKSI”) in the current year, which is HK\$48,190 per month in 2026/27. The grant is applicable only to approved applications for 2026/27 application cycles.

Eligibility Criteria

To be eligible for the grant under the EAPRS, applicants must satisfy **ALL** of the following criteria set out in these application guidelines:

Part A: Official Retirement Date – Definition, Certification and Finality

1. Applicants must have officially retired from the Team Hong Kong, China prior to submitting an application under the EAPRS. The Official Retirement Date must be supported by documentary evidence. All applications under the EAPRS must be submitted within two years from the Official Retirement Date.
 - 1.1 An Official Retirement Date is defined as the date on which the Applicants cease to be an active member of the Team Hong Kong, China and will no longer represent Hong Kong to compete in any future international competitions.
 - 1.2 The Official Retirement Date must be certified by the relevant National Sports Association (the “NSA”). The NSA concerned must be a recognized member under the Sports Federation & Olympic Committee of Hong Kong, China (the “SF&OC”). Attempts to alter or extend this date will result in disqualification.
 - 1.3 The NSA must certify and endorse the authenticity of the applicants’ retirement status, full-time training records, and competition results. The NSA is responsible for ensuring that all submitted documents are accurate and complete. Failure by the NSA to provide proper certification will render the application invalid.
 - 1.4 Once the Official Retirement Date has been certified by the NSA in accordance with clause 1.2 & 1.3, it shall be final and irrevocable. Any attempt by the applicants or the NSA to alter or adjust the Official Retirement Date for extending the 2-year eligibility period will result in disqualification from the application process.
 - 1.5 Participation in any subsequent activities does not change or extend the Official Retirement Date, including but not limited to:
 - Participation in local training sessions, domestic league, or any other events whether affiliated with the Team Hong Kong, China or not;
 - Involvement in club-level competitions or team-based engagements; or
 - Engagement in recreational sports or personal sporting activities.
 - 1.6 Applicants must provide certification or documentation for the last international competition in which they represented Team Hong Kong, China to substantiate the declared Official Retirement Date.
 - 1.7 Applicants are required to formally declare that the Official Retirement Date and all information provided are true, complete and accurate. Any false declaration or omission will result in disqualification, withdrawal of the grant, and recovery of disbursed funds.
 - 1.8 Each applicant is eligible to receive the EAPRS grant only **ONCE** during his/her sporting career. Even if the applicant resumes Team Hong Kong, China representation after receiving the EAPRS grant, he or she remains ineligible for further applications under the EAPRS. The Official Retirement Date certified in the initial application will be deemed final and irrevocable.
 - 1.9 Applicants must submit their application within two years from their Official Retirement Date.

Eligibility Criteria (Cont'd)

Part B: Sporting Achievements, Full-time Training and Residency Requirement

2. Applicants must have achieved a result equivalent to an Elite Vote (“EV”) Score of 4 points or above in accordance with the Elite Vote Support System (“EVSS”) Generic Scoring Table (i.e. medallist in events with more than 9 entries or top 1/3 placement in events with 9 or fewer entries under the Senior category at the Asian Championships, or in events of the same level or higher). Results under the Junior category will not be considered.
3. Applicants must demonstrate, to the satisfaction of the EAPRS, that they have undertaken full-time training for at least 8 years (i.e. 96 full months), prior to their Official Retirement Date. Such training must be fully supported by documentary evidence. Any training period that is not properly documented, verified, or is inconsistent with other available records shall not be recognised.
 - 3.1 The EAPRS has specific requirements regarding each applicant’s sporting achievement and full-time training record. These are measured against the full-time training standard and system set by the HKSI:
 - 3.1.1 Applicants must prioritize elite-level training and competition as their primary commitment throughout the training period;
 - 3.1.2 For the avoidance of doubt, “primary commitment” means that training must be the applicants’ principal daily activity and must not be materially inconsistent with employment, study, or other substantial engagements;
 - 3.1.3 Applicants must not hold full-time employment or be enrolled in full-time academic programmes, except where temporary deferment of the full-time study programme has been approved by the school, or arrangements have been made by the school to reduce the study contact hours to the equivalent of a part-time programme (i.e. not more than 10 contact hours per week on average). Documentation issued by the school or employer is required under these circumstances;
 - 3.1.4 Applicants must undertake supervised full-time training for a minimum of 5 days and 25 hours per week (for able-bodied athletes) or 5 days and 20 hours per week (for disabled athletes); and
 - 3.1.5 Any engagement in part-time work or studies must be approved in advance and supported by documentary proof issued by the Head Coach and the NSA. In the absence of such prior approval, the relevant training period shall not be recognised.
 - 3.1.6 Applicants must disclose all employment and study during claimed training periods, including nature, hours, and prior approval. Failure to disclose or disclosing false information will result in disqualification.
 - 3.2 Each completed year (i.e. 12 consecutive months) of full-time training undertaken by the applicants prior to the Official Retirement Date will count towards their total eligible training period. If the applicants have experienced a temporary suspension from full-time training due to health, injury or other valid reasons as recognized by the NSA and the Head Coach or Supervising Coach, the Applicants’ prior Full-Time Training periods may nevertheless be taken into account when determining eligibility under the EAPRS.
 - 3.3 Any period during which the applicant was employed by the HKSI as a training partner will not be considered as eligible full-time training under the EAPRS criteria.
 - 3.4 For any training period not recorded by the HKSI, the applicants must provide documentary evidence sufficient to establish continuous, structured and supervised full-time training, including: training logs, NSA certification and relevant supporting documents. Retrospectively compiled or fragmented records will be disregarded. Where training involves multiple organisations, the applicants must provide a clear chronological breakdown demonstrating continuity and sufficient supporting proof.
 - 3.5 For any full-time training periods NOT recorded by the HKSI, the applicants must submit all of the following:
 - (a) Approved full-time training logs signed by the applicants, their Coach, and the NSA, clearly indicating weekly full-time training hours and continuity of full-time status;
 - (b) An official letter from the NSA confirming endorsement of the claimed full-time training periods, including details of the full-time training arrangement (e.g. club-based, overseas, or multi-club arrangements). The NSA letter must also include an accountability statement confirming that the NSA accepts responsibility for the accuracy of the endorsement;
 - (c) Supporting documents certifying the applicants’ sporting results, full-time training periods, and Official Retirement Date (if applicable);
 - (d) Evidence of full-time status during the claimed training periods, which may include tax records or equivalent documents demonstrating that the applicants were not engaged in full-time employment outside sport.
4. For the purposes of EAPRS eligibility, Applicants must have resided in Hong Kong for a continuous period of not less than three (3) years immediately preceding the date of application, hold a valid Hong Kong Identity Card at the time of application, and provide documentary evidence satisfactory to the EAPRS to establish compliance with these requirements.
5. Any sporting result relied upon by the Applicants for the purpose of satisfying the sporting achievement requirement under the EAPRS must satisfy the applicable eligibility requirements prescribed under the Elite Vote Support System (EVSS), including any residency and representation requirements applicable to that result.
6. Where the Applicants rely on a result obtained in a team event or in any event involving team participation, the relevant result will only be recognised if, at the time of that competition, all relevant team members satisfied the applicable residency and/or representation requirements under the relevant EVSS and any other requirements applicable to that result. For Tier A* and Tier A Sports, the relevant team members must also have been eligible to represent Hong Kong in the Asian Games or Olympic Games, as applicable.
 - 6.1 Applicants bear the responsibility of providing sufficient supporting information to enable the EAPRS to verify the eligibility of the relevant team result, including details of the team members and supporting certification from the NSA.
 - 6.2 In assessing team-event results, the EAPRS and the Vetting Committee may rely on certification and supporting information provided by the NSA, unless there is reason to doubt its accuracy or completeness.
 - 6.3 If the residency and/or representation eligibility of the relevant team members cannot be satisfactorily established, the relevant team result shall not be recognised for the purposes of the EAPRS.
7. For the avoidance of doubt, the Applicants shall be responsible for satisfying their own eligibility requirements under the EAPRS, including the residency requirement.
8. The EAPRS may verify residency status with relevant authorities as it deems fit.

Eligibility Criteria (Cont'd)

Part C: Important Note – Documentation, Verification and Integrity

9. The EAPRS reserves the right to request applicants to provide additional supporting documentation or information to verify any details stated in the application. Applicants carry full responsibility for submitting complete documentation at the time of application. Incomplete submissions will be rejected as ineligible.
10. A general letter of support or endorsement without verification will not be regarded as certification for the purposes of the EAPRS.
11. Failure to submit the above-mentioned supporting documents within the time frame specified by EAPRS will render the application ineligible for further consideration.
12. Any inconsistency between the information provided by the Applicants and independently obtained records will be taken into account in determining eligibility.
13. Any false statement, misrepresentation or omission of material facts in an application will result in immediate disqualification, cancellation or withdrawal of any grant award, recovery of any funds already disbursed, and/or such other action as the EAPRS considers appropriate. The EAPRS reserves the right to verify the accuracy of information provided and to pursue recovery by administrative or legal means where necessary.
14. The EAPRS reserves the right to refuse to recognise any undocumented, insufficiently evidenced, retrospectively compiled, fragmented or unendorsed training periods.
15. The EAPRS and the Vetting Committee shall be entitled to place such weight as they consider appropriate on any certification provided by the NSA and may disregard any information that is not adequately supported or verified.
16. The Vetting Committee of the EAPRS reserves the right to interpret all eligibility criteria and to determine whether an application meets EAPRS standards. The Vetting Committee may accept additional documents, request further information, or make procedural exceptions as it considers appropriate. The decision of the Vetting Committee on the applicants' eligibility is final and binding.

Procedure of Application, Approval and Appeal

Application Procedure

17. Applications are invited twice a year (around July and December).
18. Applicants must complete and submit the official [application form](#) (downloadable from the HKSI website), together with all required supporting documents to the Athlete Affairs Department of the HKSI by the specified deadline.
19. Applications must be submitted within two years from the Official Retirement Date. This two-year period represents the period when eligibility lasts for an application but not a mandatory waiting period. Late applications will not be accepted under any circumstances.
20. Applicants bear the burden of proof to establish eligibility. The EAPRS is not obliged to obtain or reconstruct evidence on behalf of the applicants.
21. Any false statement, misrepresentation, or omission of material facts in the application will result in immediate disqualification, withdrawal of the grant, and/or recovery of funds disbursed. The EAPRS reserves the right to investigate and verify any information provided.
22. Applicants must formally declare accountability for the accuracy of all claims and documents submitted. Failure to provide complete and verifiable documentary evidence will result in rejection. Explanations alone will not be accepted.

Approval Procedure

23. All applications will be vetted and reviewed by the Vetting Committee and subsequently be presented to the Elite Training and Athletes Affairs Committee of the HKSI for final approval.
24. Applicants will be notified of the result following the EAPRS's decision. Approved grants will be released to the successful applicants within 2 months after the EAPRS's final decision being made.
25. Once an application has been approved, it cannot be withdrawn and resubmitted under any circumstances. This policy is in place to maintain the integrity and consistency of the application process.

Appeal Procedure

26. Applicants wishing to appeal an unsuccessful application must submit a written appeal, including full justification and supporting documentation, within 30 calendar days of the date of the official decision letter. Appeals must be submitted both by post and email.
27. Appeals must include comprehensive, factual and new documentary evidence capable of substantiating the grounds of appeal. Explanations or bare assertions without supporting documents will not be sufficient. Appeals based on incomplete, speculative or unsubstantiated claims will not be accepted. The Vetting Committee of the EAPRS retains full discretion to accept or reject appeals, and its decision is final. In exercising such discretion, the EAPRS shall have regard to the sufficiency and reliability of the documentary evidence, the consistency between submitted information and independently verified records, and compliance with all the requirements prescribed under these application guidelines. Applicants will be notified of the outcome after the EAPRS has completed its review process.
28. Once the appeal process has been concluded, no further appeal or reconsideration will be entertained. All decisions made by the Vetting Committee of the EAPRS regarding eligibility, documentation sufficiency, and grant approval are **final and binding** following the conclusion of the appeal process and for the purposes of the EAPRS's procedures.

香港運動員基金 精英運動員優秀表現嘉許計劃 申請指引 2026/27

簡介

精英運動員優秀表現嘉許計劃（「本計劃」）於 2015 年由政府在香港運動員基金下成立，旨在表彰運動員在體育領域的貢獻，以及他們代表香港在大型運動會及賽事中所取得的成就。本計劃為 2015 年 1 月 1 日或之後正式從香港代表隊退役的運動員提供一次性資助，以加強對運動員退役後職業轉型以及進一步發展的支援。本計劃的主要內容如下：

資助金額

本計劃根據合資格退役運動員的運動成績精英評分及全職訓練年期，向其發放一次性現金資助。資助金額以現年度香港體育學院（「體院」）精英訓練資助評核準則「標準精英甲+」訓練資助額作參考。2026/27 年度的「標準精英甲+」訓練資助額為每月 48,190 港元。資助金額僅適用於 2026/27 年度申請周期中獲批的申請。

申請資格準則

為符合本計劃之資助資格，申請人必須同時符合申請指引內列明之下列**所有**準則：

甲部分：正式退役日期一定義、證明及最終性

- 申請人根據本計劃提交申請前，必須已正式從中國香港代表隊退役。該正式退役日期必須提供證明文件予以佐證。所有本計劃下提出的申請必須在正式退役日期起計 2 年內提交。
 - 「正式退役日期」指申請人不再為中國香港代表隊的現役成員及不會再代表中國香港參與任何未來國際比賽的日期。
 - 正式退役日期必須由相關體育總會（「體育總會」）證明。體育總會必須為中國香港體育協會暨奧林匹克委員會（「港協暨奧委會」）所認可之成員。任何企圖更改或延長該日期之行為，將導致申請被取消資格。
 - 體育總會必須證明並確認申請人的退役狀態、全職訓練紀錄及比賽成績之真實性。體育總會有責任確保所提交的文件均為準確及齊全。如體育總會未能提供適當的證明，該申請將被視為無效。
 - 一旦正式退役日期獲體育總會依據第 1.2 及第 1.3 條證明，即為最終退役日期且不可撤銷。任何由申請人或體育總會作出企圖更改或調整正式退役日期以延長兩年申請資格期之行為，將導致申請被取消資格。
 - 參與任何後續活動並不會導致正式退役日期被更改或延長，包括但不限於：
 - 參與本地訓練、本地聯賽或任何其他與香港代表隊有關或無關的活動；
 - 參與屬會級別的比赛及團隊活動；或
 - 進行休閒運動或個人體育活動；
 - 申請人必須提交其最後一次代表中國香港代表隊出戰之國際賽事的證明文件，以證明所申報之正式退役日期屬實。
 - 申請人必須正式聲明所申報之正式退役日期及提供之所有資料均屬真實、完整及準確。任何虛假聲明或遺漏，將導致申請被取消資格、已批資助被撤回，及遭收回已發放之款項。
 - 每名申請人於其運動生涯中僅可獲發本計劃資助**一次**。即使申請人於領取本計劃資助後恢復代表中國香港代表隊出賽，申請人仍不合資格再次就本計劃作出申請。首份申請中經證明之正式退役日期將被視為最終申請且不可撤銷。
 - 申請人必須於其正式退役日期起 2 年內提交申請。

申請資格準則（續）

乙部分：運動成績、全職訓練與居住身份要求

2. 申請人必須達到相等於根據「精英訓練資助評核準則- Elite Vote Support System」(EVSS) 計分表精英評分 4 分或以上的成績（即在亞洲錦標賽成年組別、同級或更高級別的賽事中，在參賽多於 9 人／隊的賽事取得獎牌或在參賽少於或等於 9 人／隊的賽事（取得排名前三分之一的成績））。青少年組別的成績不獲考慮。
3. 申請人必須證明並達至本計劃認可其在正式退役日期前，已接受合共最少 8 年（即 96 個完整月份）的全職訓練。必須提供上述訓練期完整的證明文件，予以佐證。但凡有任何訓練期未能妥善記錄、核實，或與其他現存紀錄不符，將一概不予承認。
 - 3.1 本計劃對申請人的體育成績和全職訓練記錄具特定要求。申請人的體育成績和全職訓練會以體院制定的全職訓練標準和制度來衡量：
 - 3.1.1 申請人在受訓期間必須以精英運動訓練及比賽作為其首要投入；
 - 3.1.2 為免生疑問，「首要投入」是指訓練必須為申請人的每日主要活動，且不得與其受雇工作、學業或其他重大事務／活動在實質上有所抵觸。
 - 3.1.3 申請人必須沒有擔任全職工作或修讀全日制課程，除非得到校方批准暫停修讀全日制課程或獲得到校方安排修讀時數減至與兼讀制課程時數相同（即每週平均不多於 10 個上課時數）。在此情況下，申請人必須出示由校方或僱主提供的證明文件；
 - 3.1.4 申請人必須接受每週最少 5 天及 25 小時（適用於健全運動員），或每週最少 5 天及 20 小時（適用於殘疾運動員）經督導的全職訓練；及
 - 3.1.5 任何受訓期間擔任的兼職工作或修讀的兼讀制課程須事先獲其總教練及體育總會批准，並須提交由總教練及體育總會簽發的證明文件。如未取得上述事先批准，相關的全職訓練期將一概不獲承認。
 - 3.1.6 申請人必須披露在申報的訓練期間內之所有就業及修讀課程紀錄，包括工作或課程性質、時數及事先批准的情況。凡未有披露或提供虛假資料，將一概被取消資格。
 - 3.2 申請人在正式退役日期前所完成的每一個完整年度（即連續十二個月）的全職訓練，均會計入其合資格的總訓練年期。倘申請人因健康原因、傷患或其他經體育總會及總教練或負責教練認可之正當理由而暫停全職訓練，其於暫停前完成之全職訓練年期，仍可在評估其是否符合本計劃申請資格時獲予考慮。
 - 3.3 申請人任何受僱於香港體育學院為陪練員的時間將不獲視為符合本計劃準則的全職訓練期。
 - 3.4 凡非由香港體育學院記錄之任何訓練期，申請人必須提供充足的證明文件，以確認該段訓練期屬連續性、具系統性並受監督之全職訓練，包括：訓練紀錄、體育總會的認證及相關證明文件。事後補編或不完整的紀錄將不予受理。若訓練涉及多個機構，申請人必須提交清晰的按時序編排之細目並附上充足的證明文件，以證明其全職訓練的連續性。
 - 3.5 就任何未記載於香港體育學院紀錄內的全職訓練期，申請人必須提交以下全部資料：
 - (a) 由申請人、其教練及體育總會簽署之核准全職訓練紀錄，清楚列明每週全職訓練時數，以及顯示全職訓練身分的連續性；
 - (b) 由體育總會發出之證明信，確認認可所申報之全職訓練期包括全職訓練的具體安排（例如：屬會、海外或跨會安排）。該信函必須包含體育總會之責任聲明，確認其對上述證明內容之準確性承擔責任；
 - (c) 核證申請人比賽成績、全職訓練期及正式退役日期之證明文件（如適用）；
 - (d) 證明申請人在所申報訓練期間維持全職訓練身分之證明文件，包括但不限於稅務紀錄或其他等效文件，以顯示申請人在該等期間並未從事體育運動以外的全職工作。
4. 就本計劃的申請資格而言，申請人必須於提出申請日期前已在香港連續居住不少於三（3）年，並於申請時持有有效香港身份證。申請人須提供令本計劃信納的證明文件，以證明其符合上述資格要求。
5. 申請人就符合本計劃之運動成就資格要求而援引的任何運動成績，必須符合「精英訓練資助評核準則- Elite Vote Support System」(EVSS) 所訂明並適用於該項成績的各項資格規定，包括任何有關居留資格及代表香港參賽資格的規定。
6. 倘申請人援引隊際項目成績或任何涉及團隊參與之賽事成績作為申請依據，則只有在有關賽事舉行時，所有相關隊員均符合 EVSS 所訂明並適用於該項成績之居留資格及／或代表資格規定，以及適用於該項成績的其他資格要求的情況下，有關成績方可獲本計劃認可。就 A* 級及 A 級體育項目而言，有關隊員亦必須於當時符合代表香港參加亞運會或奧運會（視乎適用情況而定）的資格。
 - 6.1 申請人有責任提供充足的證明資料，以確保本計劃能核實相關隊際成績的資格，包括隊員的詳細資料，以及由體育總會遞交的證明文件。
 - 6.2 在評估隊際項目成績時，本計劃及審核委員會可依據體育總會所提供的認證及證明資料作出評估，惟如有合理理由懷疑該等資料的準確性或完整性，則可拒絕接納。
 - 6.3 如未能充分證明相關隊員符合有關居留及／或代表資格要求，則有關隊際項目成績將不獲本計劃認可。
7. 為免生疑問，申請人必須負責證明其本身符合本計劃下的申請資格規定，包括居港要求。
8. 本計劃可在其認為適當的情況下，向有關當局核實申請人的居港狀況。

申請資格準則（續）

丙部分：重要須知—文件、核實與誠信

9. 本計劃保留權利要求申請人提供額外支持文件或資料，以核實申請表內所申報的任何詳情。申請人負有全責在提交申請時遞交完整證明文件。文件不齊全的申請將被視為不合資格並予以拒絕。
10. 就本計劃而言，未附帶核實證明之一般支持信或推薦信，將一概不被視為有效證明。
11. 未能於本計劃下指定的時間內提交上述證明文件，將導致該申請被視為不符合資格，且不獲進一步處理。
12. 申請人所提供的資料與獨立獲取的紀錄的任何不符之處將在評定申請資格時納入考慮。
13. 如申請人於申請中作出任何虛假陳述、失實陳述或遺漏重大事實，其申請可被即時取消資格，任何已批核或已發放之資助可被取消或撤銷，而任何已支付之款項亦可被追回；此外，本計劃亦可採取其認為適當的其他措施。本計劃保留權利核實申請人所提供資料之準確性，並在有需要時透過行政或法律途徑追討任何應予退還之款項。
14. 本計劃保留權利，拒絕承認任何缺乏證明文件、證據不足、事後編製、不完整或未經核證的訓練期。
15. 本計劃及審核委員會有權就體育總會所提供的核證予以其認為合適的比重，並可對任何缺乏充分支持或核實的資料不予理會。
16. 本計劃之審核委員會保留對所有申請資格條件作出詮釋及決定申請是否符合本計劃之標準的權利。審核委員會可按其認為合適的情況下接納額外文件、要求進一步資料或在程序上作出例外處理。審核委員會就申請人資格所作之決定均為最終決定，並具約束力。

申請、審批及上訴程序

申請程序

17. 本計劃每年接受兩輪申請（約於 7 月及 12 月）。
